RECTIFICATION	The data subject shall have the right to obtain, without undue delay, from the data controller, rectification of incorrect personal data concerning them. Taking into account the purposes of the processing, the data subject shall have the right to have any incomplete personal data completed, including by way of an additional declaration in accordance with the provisions of Article 16 of Regulation (EU) 2016/679.
